

Patient asked about 'medical assistance in dying' as critics say euthanasia has spiralled out of control

A woman undergoing life-saving cancer surgery in Canada was offered assisted suicide by doctors as she was about to enter the operating room. Speaking anonymously, the 51-year-old cancer patient said of the moment she was offered death instead of surgery: "It floored me... [it was] the most vulnerable I've ever felt in my life". The patient, a married grandmother from Nova Scotia, explained she was set to undergo a mastectomy operation for breast cancer when a physician asked her if she knew about medical assistance in dying (MAID).

### Canada hospital apologises for mentioning assisted suicide programme to woman seeking help for suicidal thoughts

Kathrin Mentler says she was offered medical assistance in dying treatment after seeking psychiatric help

Kathrin Mentler, 37, told The Globe and Mail that she went to Vancouver General Hospital in June seeking treatment after her condition of longterm chronic depression was aggravated by a traumatic event.

She said she was told by a clinician that the system was "broken", and there would be a lengthy wait to see a psychiatrist. Ms Mentler told the news site she was then asked: "Have you considered MAID?"

#### Ontario man applying for medicallyassisted death as alternative to being homeless

# Woman with chemical sensitivities chose medically-assisted death after failed bid to get better housing

A 51-year-old Ontario woman with severe sensitivities to chemicals chose medically-assisted death after her desperate search for affordable housing free of cigarette smoke and chemical cleaners failed, advocates say. **"The government sees me as expendable trash, a complainer, useless and a pain in the a\*\*,"** 'Sophia' said in a video filmed on Feb. 14, eight days before her death. She died after a frantic effort by friends, supporters and even her doctors to get her safe and affordable housing in Toronto.

### Put to death': Canada's too-permissive euthanasia laws a threat to the disabled, experts say

Disabled rights advocates are troubled by instances in which people have sought to be killed because they weren't getting adequate government support to live

Alan Nichols had a history of depression and other medical issues, but none were life-threatening. When the 61-year-old was hospitalized in June 2019 over fears he might be suicidal, he asked his brother to "**bust him out**" as soon as possible.

Within a month, Nichols submitted a request to be euthanized and he was killed, despite concerns raised by his family and a nurse practitioner. His application for euthanasia listed only one health condition as the reason for his request to die: hearing loss.

# Chronically ill man releases audio of hospital staff offering assisted death

An Ontario man suffering from an incurable neurological disease has provided CTV News with audio recordings that he says are proof that hospital staff offered him medically assisted death, despite his repeated requests to live at home.

Roger Foley, 42, who earlier this year launched a landmark lawsuit against a London hospital, several health agencies, the Ontario government and the federal government, alleges that health officials will not provide him with an assisted home care team of his choosing, instead offering, among other things, medically assisted death.

# Dutch court clears doctor in landmark euthanasia trial

The patient was given fatal doses of drugs despite some indications she might have changed her mind since declaring in writing that she wanted euthanasia. To carry out the euthanasia, the physician drugged the patient's coffee without her knowledge and then had family members restrain the woman while delivering the fatal injection.

Baroness Tanni Grey-Thompson: Disabled people 'really scared' by assisted dying bill

Peer fears new law would open the door to vulnerable being 'pushed' into seeing death as their 'best' option

Vulnerable disabled people could end up being "pushed" and "coerced" into death if assisted dying is made legal, Tanni Grey-Thompson has warned. "It just will get eroded very quickly," she said. "It has in every jurisdiction [that has allowed assisted dying] – it's either changed in the law or practice has become looser."
