ANNUAL AUDITS - CLOSING DATE IS APPROACHING!

PARISHES, Religious Orders and Catholic Groups have to complete an audit each year to report on various aspects of Safeguarding arrangements. These audits are a vital part of our Safeguarding work as they allow us to see what is working well and what needs improved.

What is the deadline for the Audits?

The deadline for this year's audit is 17th February 2023.

How do I complete the Audit?

Information was sent out previously to Parish Priests and Parish Safeguarding Coordinators. The Audit must be submitted online via an internet link that has been supplied. We have also supplied a PDF document with the questions on it but this document is only so that you can plan your return. The actual return must be done using the online link.

What happens after I've submitted it?

Once the audits are submitted, they will all be examined by the Archdiocese and then an improvement plan will be presented to the Trustees for approva.

Key purposes of the annual audit are to stimulate reflection on safeguarding practice and to provide an evidence-based platform on which to plan for improving practice.

Q: Our parish gets a lot of enquiries about using the parish hall for celebrations, what should our parish be doing to ensure safeguarding standards are upheld in this situation?

A: We would recommend that you have each 'party' sign a 'Hall Let' document that outlines your parishes expectations for safeguarding and what the host is liable for.

Safeguarding Concerns

If you are concerned about the welfare of a child or adult and believe them to be at immediate risk, do not delay in contacting the Police and/or the Social Work Team in your Local Authority.

It is the mandatory policy of the Catholic Church in Scotland to report all allegations of abuse to statutory authorities, regardless of whether the abuse occurred recently or in the past, or whether the accused person is living or dead.

You should refer allegations directly to **Scott Mackenzie** the Diocesan Safeguarding Adviser (DSA), unless someone is at immediate risk - in which case you should contact the police/social work first, and then follow up with the DSA.
